

# DETERMINATION OF MERGER NOTIFICATION M/24/071 – BORD GÁIS ENERGY / SWYFT ENERGY

# Section 21 of the Competition Act 2002

Proposed acquisition by Bord Gáis Energy Limited of sole control of Ardrar Holdings Limited

# Dated: 24 December 2024

#### Introduction

 On 18 November 2024, in accordance with section 18(1)(a) of the Competition Act 2002, as amended (the "Act"), the Competition and Consumer Protection Commission (the "Commission") received a notification of a proposed acquisition whereby Bord Gáis Energy Limited ("BGE") would acquire the entire issued share capital, and thus sole control, of Ardrar Holdings Limited (the "Target") (the "Proposed Transaction").<sup>1</sup>

#### The Proposed Transaction

2. The Proposed Transaction will be implemented by way of a share purchase agreement dated 15 November 2024 between the Sellers<sup>2</sup> and BGE, a share purchase agreement dated 15 November 2024 between Enterprise Ireland and BGE, and a share purchase agreement dated 15 November 2024 between the Sellers<sup>3</sup> and BGE (the "SPAs"). Following implementation of the Proposed Transaction, BGE will acquire 100% of the issued share capital of Ardrar Holdings Limited.

#### The Undertakings Involved


#### *The Acquirer – BGE*

3. BGE is ultimately owned by Centrica plc ("Centrica"), an international energy and services company headquartered in the United Kingdom.

5. BGE's business activities consist of the following:

- <u>Boiler services</u>: This includes the sale, installation and replacement of boilers, ondemand boiler servicing and repair, and the installation of smart heating controls. These services are provided to domestic customers.
- <u>Solar PV systems</u>: BGE installs solar panel systems and ancillary products such as battery storage, hot water diverters and electric vehicle chargers for domestic customers, and agricultural and small-scale commercial clients.
- 6. In relation to the provision of boiler services in the State by BGE, the Parties provided the following information in the Notification form: "BGE employs [...] engineers on a permanent basis. BGE also provides the public with a panel of approximately [...] engineers which members of the public can engage directly. The panel of engineers appears on a website called Local Heroes. These engineers (or 'Heroes') are all vetted for insurance and appropriate qualifications by BGE. BGE provides the materials (e.g. the replacement boiler) to carry out the work, however, the contract for services is between the customer and the 'Hero' engineer. BGE does not control the prices charged by the 'Hero' engineer to perform the work. Prior to 2022, BGE used Local Heroes as its sole route to market. Since 2022, BGE sells its services directly to consumers (e.g. through its own website), and through Local Heroes."
- 7. For the financial year ending 31 December 2023, Centrica's total worldwide turnover was approximately €30.4 billion, of which approximately €1.65 billion was generated in the State.

## The Target – Ardrar Holdings Limited

- 8. Ardrar Holdings Limited is a holding company with sole control of two companies: Ardrar Limited (trading as Swyft Energy) and Ardrar Technology Limited (trading as Pipelyne).
- 9. Swyft Energy's business activities consist of the following:



- <u>Boiler services</u>: Swyft Energy's activities relating to boilers are almost exclusively in boiler installations. It also carries out minimal boiler maintenance, and the installation of smart heating controls.
- <u>Solar PV systems</u>: Swyft Energy installs solar panel systems and ancillary products such as battery storage, hot water diverters and electric vehicle chargers. These products are provided to domestic, agricultural, commercial, and industrial customers.
- 10. Pipelyne directly and wholly owns the customised customer relationship management ("CRM") software that is custom built for Swyft Energy and which is designed to support the two workstreams set out in paragraph 9. Pipelyne currently licenses the lead generation aspect of the CRM software to [...] customers at a monthly income of between €[...] and €[...] per customer (totalling revenue of €[...] in 2023).
- 11. For the financial year ending 31 December 2023, Ardrar Holdings Limited's total worldwide turnover was approximately €[...] million, of which approximately €[...] million was generated in the State.

## **Rationale for the Proposed Transaction**

12. In the notification form, the Parties state the following:

"The Purchaser intends to develop its technical and engineering capacity to deliver a high-class solar PV installation business in line with its Net Zero ambitions. Since 2021, the Target has grown a business in solar PV installations for domestic clients. The Purchaser would like to grow the Target's business and to extend the provision of solar PV installations to clients in the commercial and agri sectors."

"In particular, the Purchaser anticipates efficiencies and improved 'ways of working' by adopting the Target's operations model. The Target provides the market with a developed 'end to end' service which includes consultation, installation, grant management and post installation support. This service is delivered through a customised CRM platform (i.e., a software solution that helps manage, track, and store information related to the Target's current and



potential customers). The Purchaser has adopted technology to improve its customers' experience (e.g., by streamlining supply chain processes through its Simplified Integrated Planning and Dispatch system). [...]."

## Contact with the undertakings involved

13. During the review of the Proposed Transaction, the Commission requested and received further information and clarifications from the Parties.

## **Third-Party Submissions**

14. No third-party submissions were received.

## **Competitive Analysis**

## Horizontal overlap

15. There is a horizontal overlap between the Parties in the State in the provision of boiler services, including boiler installations and boiler maintenance, and in the provision of solar PV systems.

## Vertical relationships

16. There is a minor vertical relationship between the Parties in the State since Swyft Energy purchases a small number ([...]) of smart heating control products from the Centrica group.<sup>4</sup> There is also a minor potential vertical relationship between the Parties in the State as BGE purchases certain boiler maintenance and smart heating control products from within the Centrica group rather than from third-party merchants.

## **Relevant Markets**

# Relevant Product Markets

17. In relation to the provision of boiler services, the Commission has not firmly concluded upon a relevant product market in previous determinations. In *M/07/030 - Glen Electric Limited/Glen Dimplex Group/Applied Energy Holdings Limited,* the Commission's predecessor, the Competition Authority (the "Authority"), identified the relevant product market as at least the provision of electric, gas-fired and oil-fired primary space heating products.<sup>5</sup>

- 18. In *M/18/027 SSE Airtricity/Marron Activ8*, the Commission considered an acquisition involving companies which were both involved in the provision of solar energy systems. The Commission did not define precise relevant product markets, as it was not necessary to do so. However, the Commission did analyse the impact of that transaction by reference to the following potential product markets: (i) the provision of solar thermal systems, and (ii) the provision of solar PV systems.<sup>6</sup>
- 19. The Commission defines markets to the extent necessary depending on the particular circumstances of a given case. In this instance, it is not necessary for the Commission to define precise relevant product markets because doing so will not alter the Commission's assessment of the likely competitive impact of the Proposed Transaction. For the purposes of its competitive assessment, the Commission has assessed the Proposed Transaction by reference to the following three potential product markets:
  - The provision of boiler installation services;
  - The provision of boiler maintenance services; and,
  - The provision of solar PV systems.

# Relevant Geographic Market

- 20. In *M/07/030 Glen Electric Limited/Glen Dimplex Group/Applied Energy Holdings Limited*, the Authority took the view that the relevant geographic market for the provision of electric, gas-fired and oil-fired primary space heating products was at least the State.
- 21. In *M/18/027 SSE Airtricity/Marron Activ8*, the Commission analysed the competitive impact of that transaction in the potential market for the provision of solar PV systems in the State.
- 22. In this instance, it is not necessary for the Commission to define precise relevant geographic markets because doing so will not alter the Commission's assessment of the likely competitive impact of the Proposed Transaction. For the purposes of its competitive assessment, the Commission has assessed the competitive impact of the Proposed Transaction on a national basis.

## Conclusion on Relevant Markets

- 23. The Commission has assessed the likely competitive impact of the Proposed Transaction by reference to the following three potential markets:
  - The provision of boiler installation services in the State;
  - The provision of boiler maintenance services in the State; and,
  - The provision of solar PV systems in the State.

#### **Competitive Assessment**

#### **Horizontal Effects**

#### The Provision of Boiler Installation Services in the State

24. Tables 1 and 2 below provide estimated shares for the Parties in the provision of boiler installation services in the State in 2023.

- 25. As set out in Tables 1 and 2 above, BGE's share in the provision of boiler installation services in the State following implementation of the Proposed Transaction will not exceed [...]%.<sup>11</sup> Furthermore, the increment in BGE's share in the provision of boiler installation services in the State following implementation of the Proposed Transaction will be only [0-5]% by value (or [0-5]% by volume).
- 26. Following implementation of the Proposed Transaction, BGE will continue to face competition from a number of suppliers of boiler installation services in the State, including Gaswise Limited, Harris Heating and Renewables, DeWAR Gas Service, Dublin Gas Works, and Gas Junction. The Parties state in the Notification Form that the Registered Gas Installer website<sup>12</sup> lists 662 companies active in the provision of boiler installation services in the State.
- 27. In light of the above, the Commission considers that the Proposed Transaction does not raise any horizontal competition concerns in the provision of boiler installation services in the State.

# The Provision of Boiler Maintenance Services in the State

28. Tables 3 and 4, below, provide estimated shares for the Parties in the provision of boiler maintenance services in the State in 2023.

29. Swyft Energy generated minimal turnover in the State in 2023 in the provision of boiler maintenance services.<sup>15</sup> The increment in BGE's share in the provision of boiler maintenance

services in the State following implementation of the Proposed Transaction will be less than [0-5]%. BGE's share in the provision of boiler maintenance services in the State following implementation of the Proposed Transaction will not exceed [20-25]% by value or by volume.

- 30. Following implementation of the Proposed Transaction, BGE will continue to face competition from a number of suppliers of boiler maintenance services in the State, including Gaswise Limited, Harris Heating and Renewables, DeWAR Gas Service, Dublin Gas Works, and Gas Junction. The Parties state in the Notification Form that the potential market for the provision of boiler maintenance services is fragmented and serviced by many independent contractors.
- 31. In light of the above, the Commission considers that the Proposed Transaction does not raise any horizontal competition concerns in the provision of boiler maintenance services in the State.

## The Provision of Solar PV Systems in the State

**32.** In the Notification Form, the Parties provided share estimates in the provision of solar PV systems in the State in 2023.<sup>16</sup> These are presented in Table 5 below.

- 33. BGE had a negligible share in the provision of solar PV systems in the State in 2023, carrying out only [...] solar PV installations in total, with an approximate combined value of €[...]m.
- 34. The increment in BGE's share in the provision of solar PV systems in the State following implementation of the Proposed Transaction will be only [0-5]%.

- 35. Following implementation of the Proposed Transaction, BGE will continue to face competition from a number of suppliers of solar PV systems in the State, including Activ8 Solar Energies, PV Generation Limited, Electric Ireland, and Pinergy Solar Electric.
- 36. In light of the above, the Commission considers that the Proposed Transaction does not raise any horizontal competition concerns in the provision of solar PV systems in the State.

## Non-Horizontal Effects

## Vertical Relationship

- **37.** As noted above, there is a minor vertical relationship between the Parties in the State since Swyft Energy purchases a small number of smart heating control products from the Centrica group. There is a minor potential vertical relationship between the Parties in the State as BGE purchases certain boiler maintenance and smart heating control products from within the Centrica group rather than from third-party merchants.<sup>17</sup> There is no prospect, however, of the Proposed Transaction raising any vertical foreclosure concerns since, as set out in Tables 1, 2 and 5 above, BGE's share in the provision of boiler installation services in the State following implementation of the Proposed Transaction will not exceed [10-15]% by value or by volume and will be less than [0-5]% in the provision of solar PV systems in the State. As noted above, there are many competing suppliers of boiler installation services and solar PV systems currently active in the State.
- 38. Therefore, the Commission considers that the Proposed Transaction does not raise any vertical competition concerns in the State.

## **Conclusion of Competitive Analysis**

**39**. In light of the above, the Commission considers that the Proposed Transaction will not substantially lessen competition in any market for goods or services in the State.

## **Ancillary Restraints**

40. No ancillary restraints were notified.

# Determination

The Competition and Consumer Protection Commission, in accordance with section 21(2)(a) of the Competition Act 2002, as amended, has determined that, in its opinion, the result of the proposed acquisition whereby Bord Gáis Energy Limited would acquire the entire issued share capital, and thus sole control, of Ardrar Holdings Limited, will not be to substantially lessen competition in any market for goods or services in the State, and, accordingly, that the acquisition may be put into effect.
