

DETERMINATION OF MERGER NOTIFICATION M/25/009 – IVC EVIDENSIA IRELAND/OLD CHURCH VETERINARY HOSPITAL (XL VETS GROUP)

Section 21 of the Competition Act 2002

Proposed acquisition by Independent Vetcare (Ireland) Limited of Airmid Veterinary Limited t/a Old Church Veterinary Hospital

Dated: 20 March 2025

Introduction

1. On 7 February 2025, in accordance with section 18(3) of the Competition Act 2002, as amended (the "Act"), the Competition and Consumer Protection Commission (the "Commission") received a notification of a proposed acquisition whereby Independent Vetcare (Ireland) Limited ("IVCI") would acquire the entire issued share capital, and thus sole control, of Airmid Veterinary Limited t/a the Old Church Veterinary Hospital ("OCV") (together "the Parties") (the "Proposed Transaction").

The Proposed Transaction

2. The Proposed Transaction is to be implemented pursuant to a Share Purchase Agreement, dated 3 January 2025, between IVCI, Emberdale Limited and Pursuant to the SPA, IVCI will acquire the entire issued share capital, and thus sole control, of OCV.



The Undertakings Involved

The Acquirer - IVCE and IVCI

- 3. IVCI is a wholly owned subsidiary of IVC Acquisition Limited, which in turn is a member of the IVC Evidensia group of companies ("IVCE").² IVCE is a global provider of veterinary care and ancillary services, which is headquartered in the United Kingdom. Its network includes 2,600 clinics, hospitals and out of hours centres in 19 countries worldwide.
- 4. IVCE operates in the State through IVCI, and trades as "IVC Evidensia Ireland". IVCI's portfolio in the State comprises 37 veterinary practices, operating from 56 sites. IVCI employs veterinary practitioners in the State.
- 5. Table 1 lists the veterinary practices owned by IVCI in the State.

The Target – OCV

- 7. OCV is an independent veterinary practice, currently owned by Mr Nick Garvey, which operates from three sites: Old Church Veterinary Hospital in Ballyshannon, Co. Donegal; Old Church Vets in Donegal Town; and Old Church Vets in Grange, Co. Sligo.
- 8. OCV is a member of the XL Vets Group, which is a network of independent veterinary practices which comprises 50 clinics and over 290 practitioners across the State. The XL Vets Group does not have a financial or ownership interest in OCV and is not a party to the Proposed Transaction.
- 9. For the financial year ending 28 February 2023, OCV's turnover was majority of which was generated in the State.³

Rationale for the Proposed Transaction

10. The Parties stated the following in the Merger Notification Form:

Contact with the Parties

11. During the review of the Proposed Transaction, the Commission requested and received further information and clarifications from the Parties.

Third Party Submissions

12. No third-party submission was received.

Horizontal overlap

13. There is a horizontal overlap between the Parties as both IVCI and OCV own and operate veterinary practices in the State. Both of the Parties are active in the supply of small animal care, large animal/equine care, and out-of-hours ("OOH") care.

Vertical overlap

14. There is one potential vertical overlap between the Parties.

Market Definition

Parties' views

15. The Parties state in the merger notification form that it is not necessary for the Commission to reach any firm conclusion in relation to the relevant product market or the relevant geographic



market as the Proposed Transaction does not, in their view, give rise to competition concerns on any plausible basis.⁴

Commission's Views

- 16. The Commission has previously reviewed five transactions in the veterinary sector.⁵
- 17. Four of those transactions were assessed under the Simplified Merger Notification Procedure ("SMNP").⁶ Consequently, the Commission did not consider the potential relevant market or markets in detail in those determinations.

Relevant Product Market

- 18. In *M/24/046 VetPartners/Midleton Veterinary Hospital*, the Commission, while ultimately leaving the precise product market definition open, assessed the competitive impact of that transaction by reference to the following potential product markets:
 - The provision of regular small animal care;
 - The provision of OOH small animal care; and
 - The provision of large animal care.⁷
- 19. The Commission considers it unnecessary, in this case, to assess the competitive impact of the Proposed Transaction in potential product markets corresponding to each service provided by the Parties (i.e. the provision of regular small animal care, the provision of large animal care and the provision of OOH care), as there are no horizontal overlaps between the Parties in the potential geographic markets discussed below.⁸

- 20. The Commission defines markets to the extent necessary depending on the particular circumstances of a given case. In this instance, it is not necessary for the Commission to define the precise relevant product markets because the Commission's assessment of the competitive effects of the Proposed Transaction will not be altered whether the Proposed Transaction is assessed by reference to a broad potential product market (e.g., the supply of all veterinary services) or narrow potential product markets (e.g., the provision of regular small animal care, the provision of OOH small animal care, and the provision of large animal care). However, for the purposes of its competitive assessment, the Commission considered that it is appropriate to assess OOH veterinary services separately to the supply of veterinary services during standard office hours, as the scale of service offerings tends to vary between them. Therefore, the Commission has assessed the competitive effects of the Proposed Transaction with reference to:
 - The general supply of veterinary services (i.e. the provision of both regular small animal care and large animal care); and
 - The supply of OOH veterinary services (small animal care).

Relevant Geographic Market

- 21. In *M/24/046 VetPartners/Midleton Veterinary Hospital*, the Commission, while ultimately leaving the precise geographic market definition open, assessed the competitive impact of that transaction within a local catchment area of a 45-minute drivetime from the target practice, for each of the potential relevant product markets.⁹
- 22. In the same case, the Commission considered an alternative method for identifying the local catchment area in which to assess the competitive impact of that transaction: the 80th percentile drivetime method. This method has been used by the Competition and Markets Authority ("the CMA"), in the UK, when reviewing transactions in the veterinary sector.¹⁰
- 23. The 80th percentile drivetime method involves calculating a drivetime which, when applied around a practice, describes an area within which 80% of the practice's revenues are sourced.

 The Commission did not use the 80th percentile drivetime method to delineate local catchment

areas in M/24/046 – $VetPartners/Midleton\ Veterinary\ Hospital$, as the methodology used by the parties in that case to identify the 80th percentile drive times was based on incomplete information. The Commission does consider that the 80^{th} percentile drivetime method can be an appropriate method to identify local catchment areas, where the evidence to calculate local catchment areas on this basis is sufficient, and the Commission assessed the proposed transaction in M/24/080 – $VetPartners/Greystones\ Veterinary\ Company$ using that method. 12

- 24. For the Proposed Transaction, the Parties provided 80th percentile drivetimes for each of the three OCV practices involved in the Proposed Transaction.¹³ The Parties' methodology for calculating the 80th percentile drivetimes for each OCV practice involved in the Proposed Transaction was as follows:
- 25. First, the Parties reviewed the customer database of each OCV practice and arranged the customers by the areas referenced in their listed address.¹⁴ The Parties then calculated the drivetime from each of these areas to the relevant OCV practice.
- 26. Second, the Parties, beginning with the area of closest proximity to the relevant OCV practice, calculated the total revenues generated by customers in that area. The Parties then repeated this calculation in the next closest area of proximity to the relevant OCV practice, until the sum of the revenues generated across all the areas which were included in the calculations amounted to 80% of the revenue generated by the relevant OCV site.
- 27. Third, the Parties used the drivetime distance from the area in which the 80% threshold was reached as the 80th percentile drivetime for that particular OCV practice. ¹⁵
- 28. The 80th percentile drivetimes for each OCV practice, as calculated by the Parties, are as follows:

- OCV Clinic, Donegal Town: minutes (the "Donegal Town 80th Percentile Drivetime Catchment Area");
- OCV Clinic, Grange, Co. Sligo: minutes (the "Grange, Co. Sligo, 80th Percentile Drivetime Catchment Area").
- 29. The Commission defines markets to the extent necessary depending on the particular circumstances of a given case. In this instance, it is not necessary for the Commission to define the precise relevant geographic markets because doing so will not alter the Commission's assessment of the likely competitive impact of the Proposed Transaction. For the purposes of its competitive assessment, the Commission has assessed the competitive impact of the Proposed Transaction in the general supply of veterinary services within the following local catchment areas:
 - the Ballyshannon 80th Percentile Drivetime Catchment Area;
 - the Donegal Town 80th Percentile Drivetime Catchment Area; and,
 - the Grange, Co. Sligo, 80th Percentile Drivetime Catchment Area.
- 30. In line with the Commission's approach in M/24/046 VetPartners/Midleton Veterinary Hospital, the Commission has assessed the competitive impact of the Proposed Transaction on the supply of OOH services in broader local geographic markets, described by 45-minute drivetimes¹⁶ around each of the OCV practices.¹⁷

Conclusion on relevant markets

- 31. For the purposes of carrying out its competitive assessment of the Proposed Transaction, the Commission has assessed the Proposed Transaction by reference to the following potential markets:
 - The general supply of veterinary services in: (i) the Ballyshannon 80th Percentile Drivetime Catchment Area; (ii) the Donegal Town 80th Percentile Drivetime Catchment Area; and (iii) the Grange, Co. Sligo, 80th Percentile Drivetime Catchment Area;
 - The provision of OOH veterinary services in local catchment areas described by 45-minute drivetimes around (i) Old Church Veterinary Hospital, Ballyshannon, Co. Donegal (the "Ballyshannon 45-Minute Drivetime Catchment Area"); (ii) OCV Clinic, Donegal Town (the "Donegal Town 45-Minute Drivetime Catchment Area"); and (iii) OCV Clinic, Grange, Co. Sligo (the "Grange, Co. Sligo, 45-Minute Drivetime Catchment Area")

Competitive Assessment

Horizontal effects

The Commission's approach to market shares

- 32. In *M*/24/046 *VetPartners/Midleton Veterinary Hospital*, the Commission calculated potential market shares using two different measurements.
- 33. First, the Commission calculated shares by reference to the number of veterinary practices that each supplier operated. The Commission considered that while that measurement accurately captured the number of suppliers and veterinary practices active in the local catchment area, it offered less insight into each supplier's relative size and strength.¹⁸
- 34. Second, the Commission also calculated shares based on the number of full-time equivalent vets working in each veterinary practice ("FTE vets"). The Commission considered that this measure was more likely to capture the relative size and strength of each veterinary practice and supplier in the local catchment area. The Commission noted that the calculation of shares based on the number of FTE vets working in each veterinary practice, where possible to

robustly estimate, is likely to represent a more appropriate measure for market shares in this potential relevant market.¹⁹

35. The Commission sees no reason to depart from the approach adopted in *M/24/046* – *VetPartners/Midleton Veterinary Hospital* and therefore has calculated market shares for the local catchment areas in this case on the basis of (i) the number veterinary practices operated by each supplier in the catchment area, and (ii) the number of FTE vets working in each veterinary practice.

The general supply of veterinary services

Old Church Veterinary Hospital, Ballyshannon, Co. Donegal

- 36. There are no IVCE practices in the Ballyshannon 80th Percentile Drivetime Catchment Area.
- 37. Following the implementation of the Proposed Transaction, the Parties will hold a [35-40]% share of the general supply of veterinary services, based on the number of FTE vets, in the Ballyshannon 80th Percentile Drivetime Catchment Area.
- 38. The Commission considers that the Proposed Transaction will not cause competition concerns for the general supply of veterinary services in the Ballyshannon 80th Percentile Drivetime Catchment Area because the Proposed Transaction will not cause any change in market structure, as there is no horizontal overlap between the Parties in the Ballyshannon 80th Percentile Drivetime Catchment Area.
- 39. As a sensitivity analysis, the Commission has considered a wider catchment area which includes the closest IVCE practice to Old Church Veterinary Hospital, Ballyshannon. This is The Well Pet Hospital Limited, in Tonafortes, Carraroe, Co. Sligo, which is a 41-minute drive from Ballyshannon.²⁰

- Even if The Well Pet Hospital were to be included in the Ballyshannon 80th Percentile Drivetime 40. Catchment Area, the Proposed Transaction would lead to a combined market share for the merged entity for the general supply of veterinary services in the Ballyshannon 80th Percentile Drivetime Catchment Area of [55-60]%, based on the number of FTE vets. The Commission considers that the Proposed Transaction, even on this basis, does not give rise to competition concerns as there will remain 4 alternative suppliers of veterinary services who, due to proximity, are likely to compete more closely with the Old Church Veterinary Hospital, Ballyshannon, than the Well Pet Hospital. These are: Seaview Veterinary Clinic, which operates from sites in Ballyshannon and Donegal Town; Bluestack Veterinary Clinic, which operates from sites in Donegal Town and Ballybofey; Meadowsweet Veterinary Clinic, which operates from a site in Ardtrasna, Co. Sligo; and Animalia Veterinary Centre, which operates from a site in Manorhamilton, Co. Leitrim. All of these sites are located closer to Old Church Veterinary Hospital, Ballyshannon than any other clinic which would be owned by the merged entity. As already noted, the Well Pet Hospital is located outside of the Ballyshannon 80th Percentile Drivetime Catchment Area.
- 41. Therefore, the Commission considers that the Proposed Transaction does not give rise to any horizontal competition concerns in respect of the general supply of veterinary services in the Ballyshannon 80th Percentile Drivetime Catchment Area.

Old Church Vets, Donegal Town



- 42. There are no IVCE practices in the Donegal Town 80th Percentile Drivetime Catchment Area.
- 43. Following the implementation of the Proposed Transaction, the Parties will hold a [30-35]% share of the general supply of veterinary services, based on the number of FTE vets, in the Donegal Town 80th Percentile Drivetime Catchment Area.
- 44. The Commission considers that the Proposed Transaction does not give rise to competition concerns for the general supply of veterinary services in the Donegal Town 80th Percentile Drivetime Catchment Area because the Proposed Transaction will not cause any change in market structure, as there is no horizontal overlap between the Parties in the Donegal Town 80th Percentile Drivetime Catchment Area. In addition, following the implementation of the Proposed Transaction, IVCE will continue to face a competitive constraint from 4 other veterinary practices in the Donegal Town 80th Percentile Drivetime Catchment Area, which operate from 6 sites. Table 3 lists the alternative suppliers of veterinary services in the Donegal Town 80th Percentile Drivetime Catchment Area.

- 45. The closest IVCE practice to Old Church Vets, Donegal Town is The Well Pet Hospital Limited, in Tonafortes, Carraroe, Co. Sligo, which is a 63-minute drivetime from Old Church Vets, Donegal Town. On account of the significant distance, when compared to the closer alternatives as listed in Table 3, the Commission considers it unlikely that The Well Pet Hospital exerts a significant competitive constraint on Old Church Vets, Donegal Town.
- 46. Therefore, the Commission considers that the Proposed Transaction does not give rise to any horizontal competition concerns in the general supply of veterinary services in the Donegal Town 80th Percentile Drivetime Catchment Area.

Old Church Vets, Grange, Co. Sligo

- 47. There are no IVCE practices in the Grange, Co. Sligo, 80th Percentile Drivetime Catchment Area.
- 48. Following the implementation of the Proposed Transaction, IVCE will hold a [50-55]% share of the supply of general veterinary services, based on the number of FTE vets, in the Grange, Co. Sligo 80th Percentile Drivetime Catchment Area. The only local competitor in this catchment area is Meadowsweet Veterinary Practice, Ardtrasna, Co Sligo
- 49. The Commission considers that the Proposed Transaction will not cause competition concerns for the general supply of veterinary services in the Grange, Co. Sligo 80th Percentile Drivetime Catchment Area, as the Proposed Transaction will not cause any change in market structure, as there is no horizontal overlap between the Parties in that catchment area.



50. As a sensitivity analysis, the Commission has considered a wider catchment area which includes the closest IVCE practice to Old Church Vets, Grange, Co. Sligo. This is The Well Pet Hospital, Tonafortes, Carraroe, Co. Sligo, which is a 19-minute drive from Old Church Vets, Grange, Co. Sligo.

- 51. In addition to the Well Pet Hospital, there are 3 independent alternative suppliers of veterinary services within less than a 20-minute drive from Old Church Vets, Grange, Co. Sligo. These are: Meadowsweet Veterinary Practice (6.6 minutes drivetime); Inishfree Veterinary Hospital (18-minute drivetime); and St Benedict's Veterinary Hospital (18 minutes drivetime).
- 52. The Commission considers that the Proposed Transaction will not cause competition concerns for the general supply of veterinary services within less than a 20-minute drive from Old Church Vets, Grange, Co. Sligo, for three reasons:
- 53. First, following the implementation of the Proposed Transaction, IVCE will continue to face a competitive constraint from Meadowsweet Veterinary Practice in the supply of large animal care within that local catchment area.²² There are three independent alternative suppliers of veterinary services (including Meadowstreet Veterinary Practice) within a 20-minute drive of Old Church Vets, Grange, Co. Sligo, with each being closer to Old Church Vets, Grange, than The Well Pet Hospital. These practices will exert a competitive constraint on IVCE following completion of the Proposed Transaction, as they are a relatively short drive from Old Church Vets, Grange, Co. Sligo.
- Second, the practice profiles of the Old Church Vets, Grange, and the IVCE-owned Well Pet Hospital are dissimilar. According to information provided by the Parties, [35-40]% of the services offered by Old Church Vets, Grange, are to large animals, whereas [95-100]% of services offered by the Well Pet Hospital are to small animals. While both practices offer regular small animal care, Old Church Vets, Grange, Co. Sligo is primarily involved in the provision of large animal care, which is a service that the Well Pet Hospital does not provide.
- 55. Therefore, the Commission considers that the Proposed Transaction does not give rise to any horizontal competition concerns in the general supply of veterinary services in the Grange, Co. Sligo 80th Percentile Drivetime Catchment Area or in the extended catchment area within less than a 20-minute drive from Old Church Vets, Grange, Co. Sligo.

OOH services

Old Church Veterinary Hospital, Ballyshannon, Co. Donegal

- As shown in Table 5, following the implementation of the Proposed Transaction, IVCE will hold a [35-40]% share of the supply of OOH services, on the basis of the number of sites in the Ballyshannon catchment area. There will be at least 4 alternative suppliers of OOH services, operating on a 24/7 basis, in the Ballyshannon 45-Minute Drivetime Catchment Area.
- 58. The Commission considers that the Proposed Transaction is unlikely to raise any horizontal competition concerns in the supply of OOH services in the Ballyshannon 45-Minute Drivetime Catchment Area as, following the implementation of the Proposed Transaction, there will remain a number of alternative suppliers of OOH services in the Ballyshannon 45-Minute Drivetime Catchment Area which will exert a competitive constraint on IVCE.

OCV Clinic, Donegal Town

59. Table 6 lists the practices providing OOH services within the Donegal Town 45-Minute Drivetime Catchment Area.

- 60. There is no overlap between the activities of the Parties in the supply of OOH services in the Donegal Town 45-Minute Drivetime Catchment Area. The closest IVCE practice is the Well Pet Hospital, Tonafortes, Carraroe, Co. Sligo, which is a 63-minute drive from Old Church Vets, Donegal Town.
- 61. If, as shown in Table 6, the Well Pet Hospital is included in the Donegal Town 45-Minute Drivetime Catchment Area, IVCE will hold a [35-40]% share of the supply of OOH services, on the basis of the number of sites in the Donegal Town 45-Minute Catchment Area. There will be at least 5 alternative suppliers of OOH services, operating on a 24/7 basis, in the Donegal Town 45-Minute Drivetime Catchment Area.
- 62. Even on this basis, the Commission considers that the Proposed Transaction is unlikely to raise any horizontal competition concerns in the supply of OOH services in the Donegal Town 45-Minute Drivetime Catchment Area as, following the implementation of the Proposed Transaction, there will remain a number of alternative suppliers of OOH services in the Donegal Town 45-Minute Drivetime Catchment Area, which will exert a competitive constraint on IVCE.

OCV Clinic, Grange, Co. Sligo

63. Table 7 lists the practices within the Grange, Co. Sligo 45-Minute Drivetime Catchment Area.

- 64. As shown in Table 7, following the implementation of the Proposed Transaction, IVCE will hold a [30-35]% share of the supply of OOH services, on the basis of the number of sites in the Grange, Co. Sligo 45-Minute Drivetime Catchment Area. There will be at least 7 alternative suppliers of OOH services, operating on a 24/7 basis, in the Grange, Co. Sligo 45-Minute Drivetime Catchment Area.
- 65. The Commission considers that the Proposed Transaction is unlikely to raise any horizontal competition concerns in the supply of OOH services in the Grange, Co. Sligo 45-Minute Drivetime Catchment Area as, following the implementation of the Proposed Transaction, there will remain a number of alternative suppliers of OOH services in the Grange, Co. Sligo 45-Minute Drivetime Catchment Area, which will exert a competitive constraint on IVCE.

Conclusion on horizontal effects

66. In light of the above, the Commission considers that the Proposed Transaction does not raise any horizontal competition concerns in any market for goods or services in the State.

Vertical effects

67. As noted above, there is a potential vertical overlap between the activities of the Parties.

Supply agreements

68. The potential vertical overlap arises as veterinary practices within the IVCE network with certain suppliers of pet food and medicinal products.

Pet Food

- 69. IVCE has arrangements with

 . This pet food is then sold at the veterinary practices to petowners.
- 70. The Commission considers that this potential vertical overlap does not raise competition concerns as:



- the Parties note in the merger notification form that veterinary practices within the IVCE network account for less than [0-5]% of total pet food sales in Ireland.²³
- Veterinary clinics are not the primary distribution channel for pet food sales. Pet food
 can be and is purchased from a variety of suppliers which include specialist pet and
 pet food stores, and supermarket chains such as Tesco Ireland Limited, Dunnes Stores
 and Supervalu.
- IVCE's role in the supply of pet food is not as a typical supplier, but more akin to a
 buying group; it does not currently, to the Commission's knowledge, supply outside of
 the veterinary practices within the IVCE network.
- Old Church Vets comprises three veterinary practices, meaning the Proposed
 Transaction represents a negligible overall change in the potential scale of IVCE as a
 wholesale purchaser of pet food. In addition, IVCE/IVCI's veterinary practices are not
 tied to exclusive purchasing arrangements and are free to purchase pet food outside
 of IVCE's negotiated supply arrangements.
- 71. Therefore, the Commission considers that the merged entity would have neither the ability nor incentive to engage in input foreclosure or customer foreclosure, with respect to pet food, following implementation of the Proposed Transaction.

Medicinal Products

- 72. IVCE has a number of pan-European arrangements for the supply of medicinal products at centrally negotiated rates.
- 73. The Commission considers that this potential vertical overlap does not raise competition concerns as:
 - Following the implementation of the Proposed Transaction, IVCE's share of the supply
 of veterinary services in the State will be [5-10]%, if measured by the number of
 practitioners. By inference, then, IVCE does not account for a large share of the supply
 of veterinary medicinal products in the State.

- IVCE's role in the supply of medicinal products is not as a typical supplier, but more
 akin to a buying group; it does not currently, to the Commission's knowledge, supply
 outside of the veterinary practices which are within the IVCE network.
- Old Church Vets comprises three veterinary practices, meaning the Proposed
 Transaction represents a negligible overall change in the potential scale of IVCE as a
 wholesale purchaser of medicinal products. In addition, IVCE/IVCI's veterinary
 practices are not tied to exclusive purchasing arrangements and are free to purchase
 medicinal products outside of IVCE's negotiated supply arrangements.
- 74. Therefore, the Commission considers that the merged entity would have neither the ability nor incentive to engage in input foreclosure or customer foreclosure, with respect to veterinary medicinal products, following implementation of the Proposed Transaction.

Conclusion on competitive analysis

75. In light of the above, the Commission considers that the Proposed Transaction will not substantially lessen competition in any market for goods or services in the State.

Ancillary Restraints

76. No ancillary restraints were notified.



Determination

The Competition and Consumer Protection Commission, in accordance with section 21(2)(a) of the Competition Act 2002, as amended, has determined that, in its opinion, the result of the proposed acquisition whereby Independent Vetcare (Ireland) Limited would acquire the entire issued share capital, and thus sole control, of Airmid Veterinary Limited t/a Old Church Veterinary Hospital will not be to substantially lessen competition in any market for goods or services in the State, and, accordingly, that the acquisition may be put into effect.
